

# Instructions for Submitting Academic Early Alerts for Summer Session II 2022 Courses on Advise (Kean USA only)

All instructors of Kean USA undergraduate and graduate courses are required to submit Academic Early Alerts (grades and/or comments) for the students enrolled in their courses. These alerts will reflect your assessment of student performance in the beginning of the session.

Please note the following deadlines:

#### **Summer Session II, 2022**

#### Five Week Courses (July 5-August 8)

| Thursday, July 21  | Academic Early Alerts due by noon                            |
|--------------------|--|
| Wednesday, July 27 | Last day to withdraw from courses with "W" grade (no refund) |

### Six Week Courses (July 5-August 15)

| Thursday, July 28   | Academic Early Alerts due by noon                            |
|---------------------|--|
| Wednesday, August 3 | Last day to withdraw from courses with "W" grade (no refund) |

## **Eight Week ONLINE Courses (July 5-August 29)**

| Thursday, August 4 | Academic Early Alerts due by noon                            |

| Tuesday, August 9  | Last day to withdraw from courses with "W" grade (no refund) |

Academic Early Alerts are meant to provide students with early feedback on how they are performing in your class. These reports will also be shared with students' faculty advisors, special program advisors, and with <a href="Center for Advising">Center for Advising</a>, <a href="Persistence">Persistence and Retention</a> (CAPS) staff who will intervene with those students for whom you submit poor or failing grades/comments. Students whose

Academic Early Alerts indicate they are at risk for earning poor final grades will be connected with the appropriate services (e.g., tutoring, workshops, advisement, and/or counseling) to help them improve their academic performance in time to impact their final grades.

Academic Early Alerts are submitted via Advise only. Please see this <a href="short"><u>short</u></a> <a href="mailto:video">video</a> regarding this process. Reports can be submitted beginning two business days prior to the deadline. You will benefit students and their advisors by submitting progress reports as early as possible within this time frame.

The students in your class will be <u>notified</u> about the purpose and timing of Academic Early Alerts. Students will receive notification and referrals related to their Academic Early Alerts via Advise as soon as they are entered. These alerts will not appear on students' transcripts or become part of their permanent records. Academic Early Alerts are for immediate, short-term informational/advisement/intervention purposes only. Academic Early Alerts will be replaced by the final grade.

Similar to the process previously followed through KeanWise, instructors may submit a grade\*, <a href="mailto:comment/alert">comment/alert</a>, or both.

\*Appropriate grades are A, A-, B+, B, B-, C+, C, D, and F. P (Passing), S (Satisfactory) or U (Unsatisfactory) are also options if the course is a Pass/Fail course. Grades of P, S, U, or F should be accompanied by the appropriate comment(s). Incomplete is not a valid Academic Early Alert.
